**1st PROVISIONAL PANEL FOR APPOINTMENT IN Jr.TRACKMAN (now Track Maintainer Gr.IV),
TOKEN PORTER , HELPER AND HOSPITAL ATTENDANT/SAFAIWALA IN PAY BAND-1
(RS.5200-20200) AND GRADE PAY OF RS.1800/-**

Notification was issued vide E.N. No. ECoR/RRC/D/2013 dated 12.10.2013 to fill up 1626 vacancies in various erstwhile Group-D posts in East Coast Railway.

Based on the performance of the candidates in the Written Test and Physically Efficiency Test (PET), qualified candidates in the order of merit position were called for document verification and medical examination.

After being found eligible in all respects and passing the prescribed medical examination, a **1st PROVISIONAL PANEL of 1446 candidates (UR-752 OBC-380 SC-217 ST-97), inclusive of 39 PWDs (11-HH, 13-OH & 15-VH) and 2 Ex.Servicemen (ESM)**, is being published. Appointments shall be subject to fulfillment of all the recruitment conditions/formalities as envisaged in Railway Rules

It may be mentioned here that only 30 notified posts of Safaiwala/Hospital Attendant required Cee-One (C-1) medical standard. All other posts, notified, required higher medical standard than Cee-One (C-1). Therefore, only 30 candidates having Cee-One (C-1) medical standard, in order of merit, have been pooled for empanelment. And all candidates lower in merit having C-1 medical standard, could not be empanelled.

Five (5) posts of PWD (HH) could not be filled up since there were not adequate HH candidates qualified and therefore, the five vacancies would be carried forward to next recruitment cycle as per extant provisions. Also, no more ESM candidates were found suitable.

The panel published is purely provisional. Appearance of one's name in the panel does not confer any right of appointment in Indian Railway. Appointment is subject to genuineness of the candidates in all respects to the satisfaction of the administration and availability of vacancies.

Although every care has been taken to print the correct roll numbers and other details of the selected candidates, the RRC/ECoR/BBS reserves the right to change, alter or modify the roll numbers and other details, if it is found that any error has crept in while printing the details.

The lists of successful candidates, both roll number-wise and merit order-wise, are annexed herewith.
