ENGAGEMENT OF APPRENTICES UNDER APPRENTICES ACT, 1961.

CORRIGENDUM

Please refer to the **Notification No. ECoR /RRC/Act Appr/2019** published on 07.12.2019. In continuation to the said notification, the following 2 corrigendum's are issued.

1. In Para 4 of the notification under the head of Educational qualification, the Trade 'Painter' may be read under 8^{th} Pass group. That is to say, for the Trade of Painter the minimum educational qualification is 8th class pass from recognized School and the National Trade Certificate in the notified trade issued by NCVT/SCVT.

2. The benefit of reservation under EWS can be availed upon production of an Income and Asset Certificate issued by a Competent Authority. The Income and Asset Certificate issued by any one of the following authorities in the prescribed format as given in Annexure- I shall only be accepted as candidate's claim as belonging to EWS:

a) District Magistrate/Additional District Magistrate/Collector/Deputy Commissioner/Additional Deputy Commissioner/1st Class Stipendiary Magistrate/Sub-Divisional Magistrate/Taluka Magistrate/Executive Magistrate/Extra Assistant Commissioner

b) Chief Presidency Magistrate/Additional Chief Presidency Magistrate/Presidency Magistrate c) Revenue Officer not below the rank of Tehsildar and

d) Sub-Divisional Officer of the area where the candidate and/or his family normally resides.

The candidates applying against the vacancies reserved for EWS must produce valid Income and Asset Certificate issued by competent authority as per Annexure-I on the date of Document Verification. In case of non compliance to these stipulations, their claim for reserved status under EWS will not be entertained and the candidature / application of such candidates, if fulfilling all the eligibility conditions for General (UR) category, will be considered under General (UR) vacancies only. For this Notification the financial year will be 2018-2019 as the closing date of registration is 06.01.2020

All other terms and conditions given in the above Notification shall remain unchanged.
